Every teenager is excited to take the keys and go on his or her first solo ride, so I'm sure you're ready to get behind the wheel on your own. Before then, it's important that we have a few ground rules to ensure that you are safe and that I have peace-of-mind. Car crashes kill more American teenagers than anything else, so we both need to make sure you're prepared to drive safely, with attentiveness and according to a set of rules and boundaries.

I know you'll be a fine driver, and I know you'll follow the rules we both agree on; then you can have your driving freedom and we both can have the security of knowing you'll be safe!

# Parent-Teen Driving Agreement

## BEFORE I TAKE THE CAR

- I will never let anyone else drive my car unless I have permission and I will never drive someone else's car without permission.
